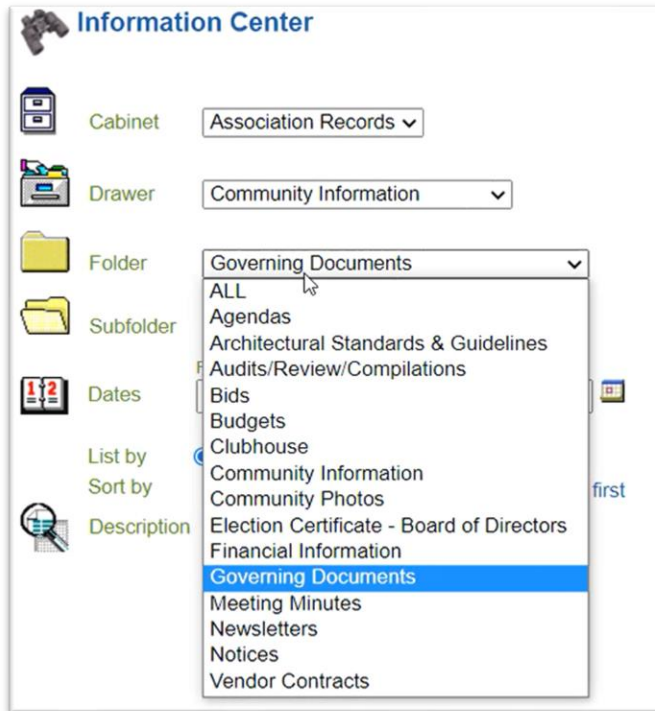
The calendar feature enables homeowners to access a master view of all community events and activities. Users have the option to sort by calendar categories to zero-in on the specific event type to be viewed.
